# PATRICIA BAREFOOT TO SPEAK PLAN TO MEET, TUESDAY, MAY 12 BRYAN-LANG HISTORICAL LIBRARY 7:00, Executive Session 6:30

Patricia Barefoot, National Park Service Ranger and Columnist, has a long-standing interest in coastal Georgia. She is a native of Glynn County, but her maternal line has deep roots in Camden. Her historical writings have covered southeast Georgia from the St. Marys River to the Altamaha and surrounding counties.

Now her interest is centered on the story of the north end of Comden County, touching particularly on the Post Road and Dover Bluff.

You will enjoy hearing the program as she enlightens, elucidates and entertains.

NOTE: Meeting will be in Woodbine, Bryan-Lang. It is located a block off US 17 near the courthouse.

## WHAT IS THE POST ROAD?

According to the historical marker located where the road crosses U.S. 17 "The road, formerly an Indian trail which paralleled the coast, was used by the Spanish and the British. In 1778 it was travelled by Revolutionary soldiers who marched against Fort Tonyn at Point Peter. (Ed. note - later studies proved that Fort Tonyn was not at Point Peter, but on the St. Marys River at the Kings Road crossing.) Albert Gallatin while U.S. Secretary of the Treasury in 1805 recommended the Old St. Marys Road, a portion of the Post Road, as one of the seven principal routes that were important in U.S. defense and postal service."

The Post Road in Carnden County extends northwest from St. Marys, forking just west of the 1-95. The Colerain section bends to the southwest toward Colerain, the site of an ancient Indian trading post on the St. Marys River. The north fork crosses Crooked River just east of its headwaters and goes northwesterly to cross the Satilla River at Jefferson.

Although no evidence of them remains, wooden markers were placed at one mile intervals along the Post Road in the last century. Even today, sites are sometimes located by referring to the "seven mile post" or "five mile post".

With time, and as new sections were added to Georgia's road system, the Post Road has been called by other names: Indian Trail, Spanish Bridle Path, Old Train Road (for wagon trains of traders and settlers), Old Market Road.

The north fork of the Post Road in Camden County led from the Satilla River to cross the Altamaha River at Fort Barrington and connect with another road leading to Savannah and with another to Milledgeville, state capital of Georgia from 1807-1867.

The Post Road marks the county line between Glynn and Brantley counties and between Glynn and Wayne. Shirley Thompson's WOODBINE TWINETH includes the photo of the granite marker near the Waycross-Brunswick highway marking the Post Road in Brantley County. This was placed there by the Brunswick Chapter of the DAR. Sections of the Post Road are still open to traffic.

## GENEALOGY CORNER

The following information comes from Society member Shirley Joiner Thompson's WOODBINE TWINETH, the history of her many Camden County lines.

CLABERNWRIGHT HARRELL and his wife Lucretia Highsmith are ancestors of Shirley Thompson and Patricia Barefoot.

Clabern Wright Harrell was born March 3, 1825 in Camden County near Tarboro, a son of Abner Harrell, Jr. and his first wife reputed to be a Taylor. He married Lucretia Highsmith, a daughter of David and Annis Highsmith. (David and Annis were first cousins) on March 14, 1850. Lucretia was born March 18, 1830.

Clabern served in the Civil War in Co. C, 4th Ga. Cav. from March 1861 to the close of the war in 1865. In 1875 Clabern received 300 acres in Camden County under the Headright and Bounty Land Acts and another 54 acres in 1887. He was a farmer and woodsman.

The Clabern Harrell large two-story house was located on the east side of the Post Road. It was built before the Civil War and the chimney brick were handmade from clay in the area. The kitchen was a separate building where the family cooked on a large wood stove. The front porch extending the length of the house was shaded by a wisteria vine. When WOODBINE TWINETH was written in 1972 the chimney still stood, and several of the old pecan trees were still alive.

Clabern Harrell died November 3, 1902 and is buried in the Crum family cemetery near the home of his son Abner Harrell. His grave is marked with a Confederate marker. Lucretia died December 17, 1905 and is buried in the Bickley Chapel Cemetery.

James Franklin (1862-1927) married Mary Etta Highsmith

John Wesley (1865-1919) married Eula Lee Tomlinson Maria Estelle (1867-1934) married Cornelius W. Drury

\* From "Footnotes" - The Georgia Historical Society has received the largest single gift in its history. Cash, portraits and papers totaling nearly \$1 million. This was a bequest from the estate of Mary Faith Wilson of Washington, D.C. and a descendant of Camden County's John Floyd.

The cash has been used to set up the John Floyd Endowment Fund with the interest to be used for operating expenses. The bequest also included family portraits and genealogical material compiled by Miss Wilson and her mother Mary Faith McAdoo Wilson.
