HISTORICAL SOCIETY TO MEET ...

Tuesday, November 12, 7:00 Guale Room, St. Marys City Library Executive Session 6:30

Anna White, Director of the Family History Center at the Church of Jesus Christ of Latter Day Saints, to speak.

She will explain the genealogical resources available to those visiting this access point for any material available in the Salt Like City Family History Library.

The main library in Utah was founded in 1895 to help families trace their ancestry and has become one of the largest of its kind in the world. The collection there includes over 1.5 million rolls of microfilm records, 200,000 microfiche and over 8 m llion family group sheets which are available to researchers.

The local center has three microfiche readers, three microfilm readers and a computer. It is located in the church building or Colerain Road next to Camden High.

The public is welcome and if you wish to visit the center, go to the rear of the church building and ring the bell. It is open Tuesday, Wednesday and Thursday - 8:30-12:30 and 6-9.

Come to the meeting on the 12th and hear Anna tell what else is available at the county's newest library.

First a correction to last issue's Gideon Mallette thanks to eagle-eye member Bill Davis. Gideon Mallette married first Sarah Brown Chevalier on January 16, 1849 (newsletter had 1852). He married Susan Lang on July 5, 1853. (July 5 is correct)

Early Casey Family Members

This information is from CAMDEN'S CHALLENGE, census and cemetery records, and other sources.

it appears that widow Jane Nichols Casey was the first Casey to move to Camden County. She is believed to be the daughter of William Nichols and born in Richmond County (Augusta). It is not known where or when her husband William Casey died. By the time of the 1830 census she was already in Camden County and listed as a head of household with 2 boys and 3 girls in her home. In 1850 she, age 60, was living with her son Abraham. She is last shown in the 1860 census, living in a house between her sons Abraham and William.

Family member Julia Casey Watson said that the original Casey place was near the Mallette place west of Kingsland and that the older Caseys were buried in a now lost cemetery near there.

In 1850, Abraham is shown as head of household with these family members in his home: his mother Jane, Elizabeth 19, Abraham 1, Ann 15, Jane 4 months and Henry 10 (a mulatto). In 1860 Camden County Census, he is 40 years old. His wife Josephine, age 26 (Higginbotham) was born in Nassau County, Florida. The children: A.D age 11, Jane E. age 9, M.A. 7, D.C. 3, Jos. 2. The 1870 census lists these children: Nancy 14, Joseph 12, John 10, Josephine 8, Fansey? 6, William 4, and unnamed child 7 months.

He and his wife are not shown in the 1880 census and may well have moved to Nassau County.

Only two marriages are known for Abraham's children. Ann married on May 17, 1854 Stephen Williams. Joseph married Georgia Ann Russell on February 15, 1877.

Jane's son William married Adeline King, daughter of Thomas King III, on February 18, 1835 in Camden County. In the 1840 Nassau County census, William is shown with his wife, a son and daughter, both under five.

In 1850, William age 42 and Adeline age 32 have these children in the home: Lucinda 15, Isaiah 11, William 8, Maria 5, Tamsey 3, Jackson 2. In 1860 Thomas age 6 was listed.

William died sometime between the 1870 census and 1880, when Adeline is shown as head of the household.

The known marriages of William's children are: Lucinda married William F. Williams, William Nichols (1842-1917) married Mary Haddock, Tamsey married John Marr, Thomas E.(1854-1932) married Jane Haddock

LETTERS FROM MEMBERS

The newly discovered grave in the Dungeness Cemetery has brought some interesting comments about its occupant (even the farout suggestion that Lighthorse Harry Lee's horse was buried there, said in jest, but recorded seriously by Times Union reporter)

Foremost Cumberland historian and Society member Mary Bullard has written this to Cumberland Island staff member Zach Kirkland and shares her thoughts with Guale News readers. "...In my opinion, the crypt may have been built in 1880 by General William George Mackay Davis, then living at Dungeness. In the spring of that year, Bernard M. Davis, his son (also living at Dungeness with his wife and family) accidentally and fatally, shot his little boy, a grandson of the general. The family was described as 'almost crazed with grief'. In December 1880 Bernard died suddenly and was interred on 2 January 1881 at Dungeness. Shortly after that, General Davis re-opened negotiations with Tom Carnegie, who had tried to make an offer to buy Dungeness in the preceding year, only to be rebuffed. The negotiations proceeded satisfactorily. The general moved from Georgia to Virginia. Davis was originally a Virginia boy, even though he lived and practiced law in Florida for a long time before the war. He was, by the way, Jeff Davis's first cousin and one of the first in Florida to offer his fortune and his person to the confederacy...."

"Nothing could be more natural in 1880 than for him to order construction of a family vault. He was planning to live at Dungeness the rest of his life.... The sudden death of his son Bernard caused him to change his mind. That is definite. He said so in his letter to Tom Carnegie...."

Another letter comes from one of the Historical Society's latest members. Marr Family Historian James F. Jamison of Zelienople, PA writes:

Dear Guale Historical Society:

I have been receiving the Guale News for some time now, and find that I enjoy it very much. ...

My chief genealogical interest in Camden County concerns the Marr family and their related families. I published one book on this family (The Descendants of John and Catherine of Kittery) in 1985. I donated a copy to the Bryan-Lang Library. Currently I am working on a second book on the Marr family entitled The Descendants of John Marr 1694-1994.

There is much I do not know about the Marrs in Camden County, but what I have learned comes mainly through the help of Juanita (Marr) Brooks of Woodbine and Dr. John Christian. I am grateful to both of them for their help....

I would like to hear from other descendants of both John and Joseph Marr who came from Maine and settled in Georgia in the 1830s. Both John and Joseph married Caseys, hence information about the Caseys would be helpful. ... (Ed. note, John Marr married Tamsey Casey June 11, 1840. Joseph married Jane Casey on April 27, 1843.)

With great thanks to those of you who have already made contributions to my knowledge of the Marrs of Camden County, and to those of you who might choose to contact me, I send greetings.
